#### **About the Work of Cornerstone**

Cornerstone Contact Centre provides emergency relief, community meals and assistance to homeless and marginalised people in Greater Dandenong. We partner with other local agencies to provide comprehensive support and care for people who are struggling, whether their challenges be financial, addiction, mental health or due to unstable family life or accommodation.





The Cornerstone pathways to employment barista training program for disadvantaged community members was a big success in 2023.

#### Programs and food relief

The core programs of Cornerstone are community meals, a gardening club in our thriving community garden, emergency relief support, along with advocacy and referral work.

In 2023 Cornerstone provided over 14,000 cooked meals, assisting homeless and marginalised locals with our breakfast, lunch and dinner programs. We offer five meal programs each week, and the housing crisis and increasing cost of living has

meant a significant increase in community members requiring food support. Along with addressing food instability for people experiencing financial hardship, the meal programs are also a valuable source of friendship, community and support for our rough-sleeping friends. #### **Advocacy Work**

Advocacy work continues to be a strong focus for the Cornerstone Contact Centre team. We are involved with the Dandenong Project Zero, an initiative that is committed to reducing homelessness to a functional zero, the Greater Dandenong Anti-Poverty Consortium, and the Dandenong West Precinct Community Safety and Rooming House action groups. Each of these panels create valuable opportunities for the Cornerstone Contact Centre team to strengthen local partnerships, broaden our team's knowledge base, and advocate for our community.
